

There will not be a large change to the assessment the CDFS program. Minimal changes would be directed towards the content of additional capstoes defined towards each specific concentration. Updates to meet expanded National Association for the Education of Young Children Standards have been put in place.

With the changes in the ECE AAS progam and altering needs of workforcewithin the early childhood field, the CDFS program was outdated and did not provide clear pathway from beginning to end leading to some student frustration. With updating and revision:

- x Major classes have been arranged so that we dents will develop a foundation of knowledge regardless of which concentration they may choose.
- x Course work from the AAS to BA pipeline will be consistent for all students.
- x The addition of capstone course within specific concentrations will support appropriate assessment of the different content, consolidating knowledge appropriately.
- x The revising of concentration areas in conjunction with the addition of Infant and Toddler concentration will support work force development within the fieldof early childhood in Alaska.
- x The revisions and additions have allowed the CES program to drop down from a 129 credit requirement to 120, meeting UArequirements for BA programs
- x Lower credit requirements support the UA initiative for more graduates in a shorter timeline.

All Faculty and staff within the CDFS program have participated with the program updating and revisions and are in complete agreement.

The information has been shared with Faculty of the ECE AAS program. All have been given opportunity for feedback.

Additional discussion was achieved through a mediated meeting haired by Rainer Newberry, where faculty from the ECE AAS and CDFS BA program arrived to this current proposal May of 2011.
